### **Deposit Contract**

This contract is for deposit on a puppy from Proffer's Kennel. This contract is entered into on this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_ between the persons known as \_\_\_\_\_ herein after referred to as the buyer and Randy Proffer herein known as the seller. The buyer agrees to purchase a \_\_\_\_\_ quality puppy from the litter of \_\_\_\_\_ known as the Sire and \_\_\_\_\_ known as the Dam. The sex of the puppy will be \_\_\_\_\_ as requested by the buyer. Color (unless brindle) can not be guaranteed by the seller before age six (6) months.

The buyer understand the purchase price for the above stated puppy will be \$\_\_\_\_\_ and a deposit of half (1/2) said amount is required to hold said puppy for buyer and against sale to another person. The seller agrees to hold said puppy for the person listed above until \_\_\_\_\_. If the above stated puppy is not paid for in full by this date, if the puppy is not picked up or the puppy can not be shipped to buyer for reasons and fault that are solely upon the buyer, the puppy may be resold to another person. **(unless regulations regarding temperature, etc. by Federal Law can not be met thus holding buyer without fault)** The buyer understands that the deposit on the above mentioned puppy is **non-refundable.**

In the event the puppy is not healthy or has died prior to vet check for shipping date or receipt of the buyer, the buyer has the option of 1. Choosing another puppy of the same quality and same sex from a different litter or 2. Waiting for a puppy from the next litter produced from the Sire and Dam listed above. The seller holds the right to refuse the sale of the puppy stated above if the seller feels they should not purchase a puppy at this time. In the event the seller chooses not to sell the puppy to the person herein listed as buyer, any and all deposits will be returned to the buyer within 3 months of the signing of this contract.

Seller agrees to deliver a healthy puppy that has been vet-checked and is up-to-date on all shots. The transfer of the puppy will be by 1. Air (or) 2. Personal Pick-up by buyer.

Buyer agrees to pay the full amount for said puppy prior to shipping or at the time of pick-up. Buyer agrees to pay all costs associated with shipping: crate, airline fees, and required health certificate. The charges for shipping on the above stated puppy will depend on size and age of puppy. Buyer acknowledges that by signing this contract they are in agreement with all terms and conditions of this contract and understand that it is a binding contract between the two parties herein stated as buyer and seller.
